A. CALL TO ORDER

The Special Meeting of January 15, 2014 of the DeSoto County Board of Supervisors was called to order by Supervisor Lee Caldwell, Board President.

D. Special Called Meeting

1. Approval of Notice of Special Called Meeting January, 15, 2014

2. NRCS – EWP Program Project Opportunities

Supervisor Mark Gardner said that Mr. Starr is Congressman Nunnelee’s field representative and he looked at the problem in his area. Supervisor Gardner thanked Mr. Starr for looking at the site and for talking to Congressman Nunnelee about the problem. He said he informed his constituent and she is elated that the information was passed on the Congressman Nunnelee.

Assistant County Engineer said they were notified by the Natural Resource Conservation Service that the Emergency Watershed Protection Program was being re-implemented. Mr. Young said that site visits were made on December 31, 2013, to evaluate eligibility based upon recent storm damage on November 22, 2013. He said the first step in the process is submitting the application and once the funds are approved, we will receive the Project Agreements. Mr. Young said it is a matching program with the County paying 25% and the Federal government paying 75%.

Mr. Scott said that site number 2 was previously approved on October 15, 2012 but he wanted it included so the Board would have a good overview of the NRCS Projects for which there is now a total of 5.

Mr. Scott said NRCS needs the applications approved by January 17, 2014.

Road Manager Andy Swims said he is very glad to see this program reinstated; one of the biggest challenges the supervisors face is drainage issues in the county.

Supervisor Jessie Medlin asked if the amount listed is the maximum the county can get. Mr. Swims said he was not sure of their dollar amount. He said it is based on the need for that particular site.

Supervisor Medlin asked if this is because of the rain event we had recently. Young said yes; we had a lot of rain in a short period of time. It counted as a qualifying rain event.

Supervisor Medlin asked if there are pictures of the sites. Mr. Young said no but they could be provided at the next board Meeting.

Supervisor Lee Caldwell said she would like to have pictures of the sites to be made part of the minutes. She said 12 sites were evaluated by the team.

Supervisor Gardner said that Mr. Herman Hill is in the audience and lives on Dixie Hill Drive. He said there is water running onto the driveway and road bed but not into the ditches and culverts which is where it should go. The water is cutting its own ditch.

Supervisor Medlin said he wants to see the pictures for these sites to try to determine what the qualifications are for these projects.

Supervisor Caldwell said she would also like to know what qualifies one project over another. She said she is very excited that Odom Road and Tulane Road will be taken care of.

Mr. Young said that Stateline Road is similar to Odom Road; there is a lot of water coming through that has caused severe erosion under the bridges.

Supervisor Caldwell said she knew they were working with the cities and asked if the Board could vote on this project today.

Board Attorney said yes.

Supervisor Gardner said he has one in District 3 and one in District 5. Supervisor Gardner said that the Wedgewood project is in the City of Olive Branch. He has talked to Mayor of Olive Branch, Scott Phillips, and he is very happy about this project.

Supervisor Gardner said that Supervisor Bill Russell discussed drafting a letter to the cities.

Supervisor Russell recommended sending as much detail as the cities need to vote on the project.

Mr. Young said after the Board approves the project agreements there are only 220 days to complete the projects; therefore any arrangements with the cities need to be made prior to project agreements being received.

Supervisor Medlin we will need to acquire right of ways; he suggested asking the cities to

participate in paying engineering and attorney fees.

Supervisor Harvey Lee asked if they were going to share costs or be reimbursed.

Supervisor Gardner said they just found out about this last week and they do not meet until next week. He said there is timing and they have called both mayors.

Supervisor Caldwell said this is a great opportunity.

Supervisor Medlin said when he was at Wedgewood, the culvert was out of the ditch.

Supervisor Gardner said when he was at Wedgewood the water moved the culvert down the ditch.

Supervisor Mark Gardner made the motion and Supervisor Jessie Medlin seconded the motion to approve proceeding with making applications for submission with NRCS for funding through the EWP program as follows:
