



Supervisor Medlin noted the administrative fees on the insurance claims had made a big jump.

Mrs. Lynchard said she noticed that too, but the numbers of employees and members also went up. She stated she will double check that and get more information out to the Board.

Supervisor Gardner asked why Neel Shaffer was taken off. Mrs. McLeod stated the fees needed to be updated. Mr. Swims stated they will make sure the fee scale is correct and on the contract.

Supervisor Medlin asked who kept up with transferred automobiles to be sure they come off the insurance. Mrs. Lynchard stated accounting and Reby Johnson work together to be sure that happens.

Supervisor Gardner asked if the insurance committee had looked at the health insurance claims cash balance as it is below what the Board had recommended. Mrs. Lynchard stated they have and that is the reason for the change in prescription drugs. She stated the Board put in \$35 per employee rather than the previous \$25 and that will help with the balance. She stated the Board's recommended balance is much larger than the insurance company recommends.

Supervisor Gardner noted the final inventory disposition for the Sheriff's Department had several radios on it. He asked if they could be used anywhere else or sold. Mrs. Lynchard stated some are not disposed of yet, and they are still getting bids to be able to sell them to the Civil Air Patrol.

Mr. Tracy Huffman of Waggoner Engineering on the behalf of the DeSoto County Regional Utility Authority (DCRUA) opened the public hearing by indicating the hearing was for the purpose of receiving public comment on the application by the DeSoto County Regional Utility Authority to amend the 2006 Solid Waste Plan of the DeSoto County Board of Supervisors.

Mr. Huffman stated the properties that will receive the biosolids from the DCRUA facilities consist of about 1,000 acres in Southeast DeSoto County along Highway 305, Byhalia Road, Ingrams Mill Road and Red Banks Road as outlined in the application that has been made available at the office of the DeSoto County Regional Utility Authority for public review.

Supervisor Lee asked if anyone was present to comment about the amendment to the DeSoto County Solid Waste Management Plan. No one came forward and no comments were received from the public.

Mr. Huffman stated he would like to acknowledge that Mr. Bill Austin, DCRUA Director; Mrs. Judy Marshall, DCRUA Administrative Assistant; and Mr. Jeff Retzke with Denali Water were present for the hearing.

Supervisor Medlin asked if they were still looking for farmers to participate in the program. Mr. Huffman stated they were, and would appreciate any referrals. He stated farms of all sizes are welcome to sign up, but typically 100-250 acre farms are used.

5. Workers Comp Benefit Policy

Mrs. Lynchard stated the Insurance Committee met a couple of times to look at the Benefits Policy and came back with 2 recommendations to the Board:

- Employees employed 1 year or more, who are unable to return to work due to workers comp injury/illness &/or other illness will be allowed to remain off duty by way of accumulated sick leave, vacation leave, and donated leave for a period not to exceed 6 months (i.e. 180 calendar days) from the date of first absence. Intermittent returns to work will not renew the 6 month time period. (Mr. Nowak stated the leave policy is in place, this recommendation just puts a "not to exceed 6-month" clause.
- Light duty classification is not to exceed 60 calendar days.

Supervisor Jessie Medlin made the motion and Supervisor Lee Caldwell seconded the motion to accept the recommendations of the Insurance Committee that the termination for employees employed 1 year or more for workers comp injury &/or illness will be not to exceed 6 months depending on the employee's ability to have sick leave, vacation leave, or donated leave; and light duty classification is not to exceed 60 calendar days.

6. MAS – Request for Resolution to Encourage Funding for LSBP

Mrs. Lynchard stated she has drafted a resolution specifically for DeSoto County to make sure the Stated knows DeSoto County Board of Supervisors does not support a fuel tax increase. Supervisor Caldwell stated she wants LSBP to be funded, but not at the expense of a fuel tax increase.

Supervisor Russell stated he was willing to go with the majority of the board on accepting the resolution, and if a fuel tax comes up, they can address how they feel about it then. Supervisor Gardner asked Mrs. Lynchard to change the wording on the resolution to say "does not support the proposed fuel tax increase".

Supervisor Caldwell stated she would like a description of what taxes will be used for, how they will trickle down to counties and cities, if they are project based, and how long they are good for.

Representative Bill Kincaid stated he did support an across the board fuel tax, but he could support it if the agencies used the tax properly. He said there has been some creative discussion at the State level on how to do that and get some of the revenue back home.

7. Mobilitie Update

Mr. Nowak stated he has drafted a letter, as requested by the Board, to send to the congressional delegates at both the state and federal level. He stated if the Board approves, he will take the same form and tweak it to send to MAS. The Board approved the letter.

Supervisor Gardner asked if there would be a hearing. Mr. Nowak stated he is keeping in touch with the counsel representing the issue, but there is no schedule yet. Supervisor Gardner asked if the Board needed to file a petition in the hearing or have a presence there. Mr. Nowak stated the petition was filed by the group, but it is looking like Mobilitie's petition will get through to some extent.

Supervisor Russell stated you have to put yourself in the shoes of legislators that are getting complaints of poor cellular service. Supervisor Caldwell added the lobbyists also have a strong influence. Mr. Nowak stated the services say they are paying too much rent to local authorities, and this would limit rents.

Supervisor Caldwell stated she just does not want to have a bunch of towers left all over the county when these companies are not using them anymore.

I. NEW BUSINESS

1. Legislators Visit

The Legislators that attended were Senator Kevin Blackwell, Representative Robert Foster, Representative Bill Kincade, and Representative Dan Eubanks.

a. Legislative Issues Update

Supervisor Gardner informed the delegation that the Board appreciated them going to bat for the County. He stated there were several bills that were asked for and did not get out of committee. He asked how the Board can help get bills to the floor.

Supervisor Caldwell stated there were 33 bills that the DeSoto County delegation worked on that did not get out of committee. Rep. Kincade said it was very frustrating. He stated there were 1386 House Bills and of those 350 were passed. He said it was a challenging year because of fiscal constraints. He stated he did not feel like they had enough focus on what was needed for their communities. Rep. Kincade said the Chairman tries to limit the number of bills, and suggested a smaller focus with the legislative requests. He suggested putting forward 8 instead of 48. He compared it to broadcasting a net and having too much slipping out of it.

Supervisor Gardner said he had been told the ³/₄ mill for fire departments had died, but then found out it was approved. He expressed the Board's thanks for that. Supervisor Caldwell stated it will give the Board more to help the 8 volunteer fire departments in the county. Supervisor Gardner stated in DeSoto County, 1/3 of the kids in public schools are protected by volunteer fire departments. Rep. Kincade stated Representative Jeff Hale is their go to man for fire legislation, and he was currently at a fire convention. Rep. Eubanks stated they all supported that legislation and that helped.

Rep. Eubanks stated if the leadership and committee chairman are not for something, it is not a priority. He cited radar in the county as a prime example. Rep. Eubanks said the Chairman of Transportation and the Speaker of the House don't want it, and it is not going to make it out of committee. Supervisor Gardner said that was a good example. He said DeSoto County has asked for radar for the past 25 years or so and gotten turned down. He said when the Sheriff's Department parks a radar trailer and records speeds exceeding 80 mph on country road, fatalities are attributed to speed.

Supervisor Lee suggested letting the State Audit Department control the radars by putting 2 in

each highly populated county. He said the Audit Department can monitor the tickets issued and determine if the radar is being abused. If it is, the county loses it. He suggested each Sheriff's Department can decide whether or not they want to use it. Supervisor Lee stated going through the Audit Department can make this a safety issue, not a revenue issue. Rep. Eubanks said he liked that idea, and if the Board will tweak that for the next session, they will see if they can track it.

Supervisor Gardner thanked the delegation for being accessible to the Board and asked if it would help for the Board to be introduced to committee chairs and members. Rep. Eubanks said anytime a chairman hears from more than just the Representatives and Senators, it is not a bad thing. Rep. Kincade stated the most effective means is to meet with committee members, not just the chairman and get committee members on board. Supervisor Caldwell stated that would be easier with fewer things on the list.

Rep. Kincade stated they have tried to be cognizant of unfunded mandates and how they affect the counties.

b. Other Legislation Passes in 2017 Session

Mrs. Lynchard stated one bill passed that gave the ability to reconfigure fire districts as long as there was not existing debt. She also mentioned a couple talking about teleconference committees and HB1116 that required notice of a called a special meeting to be posted within1 hour starting in July.

Supervisor Medlin mentioned SB2318, the request to print fewer ballots, and that it died. Senator Blackwell stated it was added into the Election Bill, and that the number of ballots has been reduced. He stated the number will be based on voter turnout. He also informed the Board that the bill called for a reduced number of training hours for resolutions boards.

Rep. Foster said many times things are piggy-backed into a bill that is similar, and they may not be the specific things. He said once the committee opens a code section to the House, it can be completely changed on the floor. He stated sometimes there is no action because of the uncertainty of what can happen.

Mrs. Lynchard stated the Board appreciated the delegation trying to get some things through. She stated there were some concerns with the Sheriff's Department and reporting money that was seized for forfeiture, HB812. Chief Deputy Macon Moore said the reporting process has changed and all seizures will now go through the District Attorney's office. He expressed concern as to what will happen to that information. He stated they are also concerned that it will take one person to do the work, and the DA's office is asking to use the forfeiture money to pay that person. He stated the other option is for the County to pay another salary.

Mrs. Lynchard stated the biggest concern at the County Administrators Conference was HB1106 & 1109 stating that all bids will have to be by reverse auction beginning in January 2018. She asked Mrs. McLeod to speak about this topic. Mrs. McLeod stated currently code allows the County to take sealed bids, reverse auction, or state contract prices. She stated HM1106 takes away the sealed bid option. Mrs. McLeod presented information that showed a recent bid that had only one bidder. She stated the bidder came in just before the deadline with a lower bid, and found at the bid opening they were the only bid. She stated if this bid had been through a reverse auction, the vendor would have seen there were no other bids and would not have lowered its bid. They also would have had to pay 3% or over \$70,000.00 to the auction company. Mrs. McLeod expressed great concern that the new legislation will require the county to use reverse auction. Rep. Foster asked if the 3% was charged by the auctioneer. Mrs. McLeod affirmed.

Supervisor Gardner asked what was the reason for looking at changing purchasing laws. Rep. Eubanks said it always toes back to corrupt deals and increasing transparency. He asked Mrs. McLeod if she felt reverse auction could ever be good. Mrs. McLeod stated they did one with election equipment in hopes of getting more bidders. She stated they only had 4 bidders, but

maybe if there were 10 or more if would be helpful. She stated the process had its advantages and disadvantages. Mrs. McLeod said the concern is that the county be able to decide which way to go. She said it seems like this code was meant for state purchasing, as they have the option to appeal to the procurement review board. Mrs. McLeod said the auditor says the procurement review board has no authority over the counties. Mr. Nowak stated part of the confusion is the language says 'purchasing entity'. Rep. Kincade suggested getting an AG opinion to clarify. Rep. Foster said he will find out if this applies to counties, and if so, is there a way to have the option to go to the procurement board.

Mrs. Lynchard stated sand and gravel people submit sealed bids, not electronic. Supervisor Caldwell stated the County also tries to buy locally, and this is not a good option for local vendors. Mrs. McLeod stated the vendor list has expanded beyond local, and she attributes that to the Jackson bidding site. She stated most of the time local vendors send in a bid response.

Rep. Foster asked if the County could set up their own auction site and run their own auction. Mrs. McLeod stated they are looking into adding that to the new software package. She said the County just found out about all this a couple of weeks ago. Mrs. Lynchard stated they were also concerned about the security issues of reverse auctions. Senator Blackwell said he was pretty sure this was set up to deal with state agencies. Rep. Foster said he only remembers discussing this bill affecting state agencies in the Accountability Committee. Senator Blackwell said he will try to get clarification. Rep. Foster said if the intent of the bill was just for state agencies, it can be determined by the Attorney General that this is only for state agencies. He stated they can put clarifying language in during the next session. He also said Jerry Turner was the author of the bill, and he would talk with him about it. Mrs. Lynchard stated the county would appreciate that.

c. Road Inventory

Supervisor Caldwell stated they wanted to put some information in the hands of the delegation showing them all the roads per district. She thanked the delegation for coming.

Rep. Kincade said they appreciate the guidance, advice and time given by the Board and will continue to work for the counties. Rep. Eubanks stated they are proud of the Board of Supervisors and County Administrator, and said both make the delegation proud and appreciative of how they manage our county. He stated he never dreamed counties could have such problems until he talked with other officials from around the state.

2. County and State Veterans Services Officers – Department Update

DeSoto County Veteran Services Officer Roy Andrews thanked the Board for the opportunity to serve the veterans of DeSoto County. Mrs. Lynchard stated Mr. Andrews was at a meeting on Saturday in Olive Branch, giving out information on Veteran Services. Mr. Andrews said he appreciated having Steve Powell to train him, and that it was a great help. He said he has been training with the State VA office, and is going next week for more training. Mr. Andrews stated in the last 6 months of FY16, he had 531 contacts, 144 interviews, and filed 44 claims. He said to date in FY17 he has had 544 contacts, 180 interviews, and filed 39 claims. He said he usually does not hear from the claims unless people have problems. Mr. Andrews said it is very rewarding to meet with a young widow and hear she got her money from the VA, and it will allow her to keep her house.

MS State Veteran Services Officer Lee Bruton said he appreciated the opportunity to address the Board. He gave a slide presentation showing veteran statistics and what Veteran Services has to offer. He said he will give the Board the numbers from 2016 when he receives them. Mr. Bruton said last year, he probably helped place 6 or 7 veterans in the State Veterans Home in Oxford. He said the veterans are happy, and the families are very pleased with the facility.

Supervisor Caldwell stated the most important thing veterans can help their families with is to let them know where their DD214 form is located. She said families have to have that. She said you must have that form to have full military honors at a funeral. Chancery Clerk Misty Heffner

stated the DD214 can be filed with the Chancery Clerk's office.

Supervisor Caldwell also said many times when a veteran passes; the families don't know who to call. Mr. Bruton stated he will get in touch with the funeral homes and give them his contact information.

Supervisor Caldwell also asked Mr. Bruton to meet with William Brooks, who is working for Congressman Kelly and a Southaven alderman, and is working with the Wounded Warriors Project. Mr. Bruton said he will contact Mr. Brooks. Supervisor Caldwell said she appreciated Mr. Bruton's efforts.

Supervisor Russell asked Mr. Bruton for his office number. He stated it as 662-449-2811.

Page 36 – Ray Allen Manufacturing - \$2149.99 – The docket showed a kennel for a new Tahoe. Chief Moore stated it was for the new K-9 Tahoe.

Page 65 – Best Western – 7 attendees structural collapse – Mrs. Hanks stated only 7 attendees of the class needed rooms. Chief Storey confirmed.

Page 67 – SPEC Rescue International – Training and Registration – Chief Storey said that is the company that trains for the State of MS. He said the class is held twice a year, one up north, and one in the south. He said it is the most expensive class they put on and is usually around \$25,000.

9. Board Attorney – MOU for Crisis Intervention Team (CIT)

Mr. Nowak stated he has been working with Chief Moore to get financial information, but he made changes to the MOU other than the financial aspect. Chief Moore stated he has met with the Chiefs of Police and they do not have any further changes. He stated they are only concerned with the potential cost of the program.

Region IV Director Charlie Spearman thanked the Board for allowing them to come and introduced Pat Sylvester, NFusion Director; Katherine Davis, Crisis Coordinator for DeSoto County; Rhett Hurley, MS Department of Mental Health, and Jason Ramey, Region IV Chief Operating Officer. He reminded the Board that, in his opinion, the MOU is not a legal, binding document, and that everyone agrees the CIT program is needed. He stated Mr. Huffman at Baptist Hospital says they are seeing these people already, and he thinks the number will decrease as officers become CIT certified. Mr. Spearman said he could not speak for Mr. Huffman, but Mr. Spearman did not think Mr. Huffman's intention was for the County to pay. Mrs. Lynchard stated if that was the case, they had been under the wrong impression. She said she will talk to Mr. Huffman. Mrs. Lynchard stated she will circulate the revised MOU to the Board and put in on the next agenda.

Mr. Spearman stated they just graduated a class of 15 officers on April 7. He said the goal is to have 25-30 per class, but they started smaller to see how it went. Supervisor Medlin asked if all the attendees were Sheriff's Deputies. Chief Moore said they were officers from all offices. Mr. Spearman stated the goal is to get as many officers trained in DeSoto County as possible, and then expand into surrounding areas.

Mrs. Lynchard asked if the conflicting protocols between CIT and EMS had been worked out. Mr. Davis said they have met and worked all that out.

Mr. Spearman also reported Region IV served 11,000 clients last year and provided over 20,000 individual services. He said the sad part of that is, they are not even scratching the surface. Supervisor Gardner asked if another CIT class had been scheduled. Ms. Davis said the next class is tentatively scheduled for September 18-22. Supervisor Gardner stated this is an invaluable service, and the more officers certified the better.

Chief Moore stated the only question was how the billing would work out; other than that they are 100% ready to go. He said having certified officers responding to scene, and calling Region IV to scene, will keep some people from going to the hospital. He stated the program in Lauderdale County works because the single point of entry is strictly for CIT. Mr. Spearman stated the CIT is called out almost every night, and he is very proud of their team.

Supervisor Russell stated Mr. Spearman is about to retire, and he hopes Region IV will keep him on in an advisory positions. Mr. Spearman stated he is hoping something like that can be worked out. He stated he has enjoyed working with the Board. Supervisor Russell thanked Mr. Spearman for what he has done for this county, saying he has "never met anyone more industrious, energetic, and inventive". Mr. Spearman stated there are some things in his life he would change if he could go back in time, but working for Region IV is something he would not change.

Supervisor Medlin stated he was skeptical of the program in the beginning, but the program has been good and he expressed his appreciation to Mr. Spearman.

Mr. Spearman stated Region IV has about 100 people working right now, and would have more if they had the space. He said he can see Region IV having 300-400 staff members in the future.

10. Grant Administration – Request Board Acceptance of WalMart Foundation Grant in the Amount of \$2,000.00

Mr. Kuntz stated the grant will provide one drone and a battery pack for the Sheriff's

Supervisor Gardner encouraged Mrs. Lynchard to keep looking because there will probably be some properties to revert back to the owner or to sell. Mrs. Lynchard stated there are several parcels that the cities have annexed and used as parks. She said the City of Southaven is ready to accept those and place them on the City's inventory, and Mr. Nowak is working with their lawyer to make that transfer. Mrs. Lynchard said she will keep bringing the parcels to the Board.

13. MACAC Conference Report

Mrs. Lynchard said it was a very good conference and she had a lot of pertinent information to share with the Board. She stated the State Audit Department is adding to their department and doing more local audits. She said they will rotate their visits.

Mrs. Lynchard said reverse auction was the biggest deal they talked about and she would like Mr. Nowak to ask for an AG opinion regarding HB1106 & HB1109.

Mrs. Lynchard said other items included:

- An education bill that recommended a mandatory amount of funding to go to schools, with no changes being made now, but it is on the radar.
- Homestead reimbursements went backward this year, and the County can expect less this year than received in the past.
- The AG talked about the Board of Supervisors and said they cannot approve a claim on the claims docket that does not comply with purchasing laws; but she believes purchasing does a good job of making sure of that in DeSoto County.
- Public Records Act made a long discussion about compliance and that the general content determines whether something is a public record. For example, if a Supervisor gets a text about county business, it is public record. There was a lot of debate on requirements to keep text messages and the obligation of the county to save text messages. There was discussion about the importance of redacting things that are not public record, and making sure the public records policy is up to date. They recommend having a public records officer to be sure the county is compliant. Recommend Mr. Nowak do training with departments, especially Justice Court, HR, Planning, and IT.
- The Secretary of State's office did a presentation of land struck off to the state. They are saying they have a lot of problem land and a lot of good land. GIS has already mapped it and Mrs. Lynchard encouraged the Board to go to GIS and see where the land is. She said there were some problems where the developer let all the common area in a subdivision go to the state. She said they found a handful that might be redeemable property.
- The State Fire Marshall spoke and said there are 752 Fire Departments in Mississippi; 633 are volunteer, 76 are combination, and 43 are career.
- PERS did an update. There will be no increase in PERS match this year, but they could not speak of future years.

16. Paramedic of the Year – Danny Eytchison

EMS Director Mark Davis stated Mr. Eytchison was recognized by the Mississippi Emergency Medical Technicians Association as the Paramedic of the Year. He said Mr. Eytchison has been teaching for about 17 years and has been working as a paramedic for 10 years.

Mrs. Lynchard stated Mr. Eytchison does most of the training for the County and it is a tremendous benefit for DeSoto County. She said he puts in lots of hours as a medic and trainer, not only for EMS but for the public. Mr. Davis stated he does EMR training for DeSoto and Tate Counties.

Supervisor Medlin stated Mr. Eytchison lives in Olive Branch and he met him many years ago when he was at the Fairhaven station. He said Mr. Eytchison is well thought of by the fire departments and citizens of the community.

17. Lake Cormorant Drainage District

Supervisor Russell stated the Lake Cormorant Drainage District used to charge \$1 per acre and they used to maintain the ditches in their district. He said if he had a problem in the past he would call the levee board and they would fix the problem. Supervisor Russell said when Tunica County was flourishing, they started funding the Lake Cormorant Drainage District and the drainage district stopped charging property owners the \$1 per acre. He said they have not had any money coming in since 2001, and now they have no money to fix drainage issues. Supervisor Russell said there were 3 board commissioners, 1 is deceased, and the other 2 are not interested in serving. He said he feels the drainage district is necessary and the Board needs to appoint commissioners. Supervisor Russell also said he just learned there is a Buck Island Drainage District that extends into DeSoto County. Mrs. Lynchard stated Mr. Nowak will need to look into that.

18. Blight Elimination Update

Mr. Kuntz stated he went to the Blight Elimination Grant Workshop and found DeSoto has only 2 areas in the unincorporated county; one in Walls, and one in Olive Branch. He stated the homeowner definitely cannot retain possession of the property; it has to be given over to the blight partner; in this case, probably North Delta. The homeowner can give the property to the County or the County can condemn and acquire the title to the property. The County then transfers the property title to the blight partner. He said the grant pays for the tearing down of structures, but the property must be maintained for 3 years or it may be sold. He said if the County gets possession of the property, they can sell it. Mr. Kuntz said DeSoto County has very little area that qualifies. No Board action was required.

1. MEMA – Temporary Structure Guidance

Planning Director Bennie Hopkins stated the Mississippi Emergency Management Agency (MEMA) has given new guidance for temporary structure in flood plain areas.
